Note:-

- i. If both the learned SCJs Swabi (SCJ-Admn & SCJ-J) are on leave/not available for any reason, the JM-I, Swabi shall perform duty of MOD for criminal work while CJ-I, Swabi shall perform duty of MOD for Civil work of the respective courts.
- ii. In case of un-avoidable circumstances at Tehsil level, if all the Civil Judges/JMs are on leave, the SCJ-(Judl:), Swabi shall perform duty of MOD of their respective courts.
- iii. Those JOs, who are already on earned or maternity leave are exempted from MOD duty till their arrival. The others JOs next in roster shall be automatically considered as MOD till the arrival of Judicial Officers, who are on leave.
